



2021 Natural Gas Conversion Rebate Application

For converting an electric appliance to natural gas

A rebate is available to encourage **Residential Customers** to install natural gas appliances. Please direct any questions to **210-353-2SAV** or visit CPS Energy website at www.cpsenergy.com for current information on funds availability.

Instruction and Conditions

- This rebate application is used to convert an electric appliance to new natural gas appliance.
- Applications must be completed and submitted within 30 days of installation of the unit.
- Applications are subject to verification. If the verification cannot be completed, the rebate will not be paid.
- The rebate recipient must be a CPS Energy natural gas customer.
- Please allow 8 to 10 weeks after receipt of all documents for the rebate to appear as a credit on your CPS Energy account.
- Appliance purchase and installation date must be from January 1, 2021 to December 31, 2021.

Rebate will cover cost of appliance, labor, permit fees and materials up to a maximum shown below. Customers are eligible for rebates on a maximum of 2 water heaters, 1 cooktop/stove and 1 dryer per customer address.

Gas water heater conversion- \$1,100.00, with \$400.00 for each additional gas water heater
 Gas dryer - \$195.00
 Gas stove or gas cooktop - \$125.00
